Procedure: **Open selection for contractor for Delivery, installation and commissioning of automated production equipment, controlling and testing of flexible water joints with the following lots:**

1.1.1 Automated production line for flexible water joints;

1.1.2 Stand for pressure testing of flexible joints;

1.1.3 Stand for tensile testing of flexible joints.

REQUIREMENTS TO THE OFFERS

When preparing the offer each applicant must adhere exactly to the conditions promulgated by “BULMAT” LTD.

The applicant may submit only one offer.

The offer must be made in accordance with the template from the documentation and must contain technical and financial proposal. The offers must be submitted in original. All required by “BULMAT” LTD documents specified in the explanatory document should be applied to the offer.

The required documents applied to the offer must be submitted in original/notarized copy and certified by the applicant with the words: “True to the original”, signature and stamp in accordance with the requirements of “BULMAT” LTD for the specific documents.

The documents, written in foreign language, should be translated by a sworn translator into Bulgarian.

It should be noted that the validity of the offers is the period of time during which the applicants are bound by the terms of the offers submitted by them.

A person who has agreed and is listed as a subcontractor in the offer of another applicant may not submit own offer.

The offer shall be submitted in sealed opaque envelop by the applicant personally or by his authorized representative or by post by registered letter with return receipt. On the envelop the applicant states:

1. name and address of the beneficiary;
2. name, mailing address, telephone and if it is possible – fax and email of the applicant;
3. name of the object of the procedure;
4. the following prescription: „Do not open before the consideration of the committee for evaluation and ranking”.

Upon acceptance of the offer on the envelop shall be marked the serial number, the date and the time of receipt and these data are recorded in the registry entry for which a document is issued for the holder.
